## **Why Create Your Own eBook**

Lots of PLR products are already formatted as ebooks, some even with cover graphics and webpages. But you can still retitle that content and name yourself as author. In most cases however, you cannot claim copyright, unless you've done significant (50% or better) rewriting.

**Benefits** - Instant credibility, the power to set your own price, market as you choose, and keep all the money. In addition, you can set up your own affiliate program when you have an "original" product of your own - and recruit others to do the selling for you.

**How To** - Most PLR ebooks come with the text formatted as a Microsoft Word .doc file. You can open that file in Word to make whatever edits you choose, add links to affiliate sites or other products of your own, your newsletter sign up page, etc.

If your computer does not have Microsoft Word on it already, you can also use [Open Office](http://OpenOffice.org) – a free software that you can set up on your computer, and that will work much like the expensive Microsoft Office Suite.

After editing, the most simple thing to do is export the edited .doc file as a .pdf – or create a free account at [pdfBuilder.com](http://pdfBuilder.com) and use their online tool to convert your .doc file to a .pdf file.

Since .pdf is the most popular ebook format today, it's important that you know how to create that type of file. If you are totally unfamiliar with that process, download the free guide at [pdfBuilder.com](http://pdfBuilder.com) for clear cut instructions.

**About the Graphics** - If you're going to change the title, and you should, you'll need to edit the graphics too. Many PLR ebooks also come with editable graphics in .psd format for Adobe Photoshop.

Don't worry - you can get "The Gimp" at no cost and do much the same things to your graphic templates as you would with Photoshop.

### ***Using Your eBook***

Think for a bit about the results you want from the ebook. Do you want to sell it for a direct profit?

Do you want to use it as a giveaway incentive to attract new subscribers and build your list?

Maybe you want to offer resale rights so others can resell your ebook and circulate your name and links Net-wide with no further effort on your part.

### **Other eBook Ideas**

Realize that you are NOT limited to creating ebooks from PLR ebook packages. Chances are you also have some private label **articles** packs already on your hard drive or saved on disc.

You can just as easily create an ebook from those articles. That effort alone can provide you with original ebooks to sell in LOTS of different market niches.

Once again, just paste the articles into Microsoft Word, in a logical sequence of course. Add a title of your choice and be sure to include your name as author and whatever links and promotions you want to circulate. Then export as or convert to a .pdf file.

Now - when you go this route, you're more or less starting from scratch.

You will not have the benefit of pre-made graphics templates, or a pre-written salesletter. You'll need to work up those resources on your own, or hire it done for you.

But in the long run it will be worth it.

There is one word that will allow you to stand out from the crowd on the Internet - and that word is "**original.**"
